

Privacy notice for apps released by Rheintacho

Rheintacho apps allow you to easily connect a wide range of mobile and plugged-in devices to Rheintacho equipment.

This privacy notice covers the following topics:

- how Rheintacho, its partners and subsidiaries (hereinafter referred to as 'Rheintacho', 'we,' 'our', or 'us'), read, collect, use and/or process data on your app usage.
- ways you can get in touch.

This privacy notice applies in conjunction with any other privacy notices that cover your interactions with one of our partner companies, subsidiaries, products, software or a service provided by Rheintacho.

1. Which apps does this privacy notice cover?

Rheintacho is permitted to collect and consolidate various data on you and your interactions with the following app when you use it:

Information on the 'RT STROBE remote' app

<u>'RT STROBE</u> remote' is an app used to evaluate the measurements taken with the corresponding device.

2. Which data relating to you do we collect and how is it used by the app?

We may directly or indirectly automatically collect the following data when you use the app:

- Device name, settings
- Browser name, language code, location, timestamp
- App data (e.g. app ID or version)
- Information on how you used the app.

Data from other features that require access permission (camera, microphone, etc.) shall not be used under any circumstances. Permission to detect your location is solely required to use Bluetooth Low Energy.

IF YOU DO NOT CONSENT TO THE COLLECTION OF THIS DATA BY RHEINTACHO, PLEASE STOP USING AND DEINSTALL THE APP.

Your data may be collected by third parties through provision of the app

3. Which other purposes does Rheintacho use your data for?

To provide certain features and functionalities

Rheintacho is permitted to collect and/or analyse the data specified in section 2 to provide the desired app features and functionalities.

To develop future products and services

Rheintacho is permitted to collect and/or analyse the data specified in section 2 and data used by you to improve our existing products and services and develop new ones.

To display targeted content, ads and recommendations

Rheintacho is permitted to collect and/or analyse the data specified in section 2 in order to provide you with tailored content e.g. to display relevant ads and recommendations. Rheintacho may send you marketing information on our services, products and events if you consent to receive this form of email correspondence.

4. Which other parties are granted access to your data?

Data disclosed to and stored by Rheintacho may be forwarded to other companies in the Rheintacho Group or third parties.

Rheintacho Group companies

Your data may be forwarded to other companies in the Rheintacho Group to pursue the activities stipulated above in sections 2 and 3.

Third parties

In certain cases, we may appoint third parties to collect, process or analyse your data on behalf of Rheintacho for the purposes conveyed in this privacy notice.

Business takeover

In the event that we sell or transfer segments of our business, or our entire company, your data may be transferred to the buyer or new owner as part of the transaction.

Compliance and enforcement

We reserve the right to store, use and/or disclose your data to the police or other competent authorities in order to investigate a complaint lodged by or against you, or to protect or defend ourselves or others against unlawful, criminal or disadvantageous activities where required or permitted by law, regulations or official instructions.

5. Storing and handling your data

We shall store the data specified in section 2 for the duration of the time you use our app and an appropriate period thereafter. If you would like us to erase the data you have provided on the app, please contact us at datenschutz@rheintacho.de. We will respond to you in a suitable manner within a reasonable time frame. Please keep in mind that some, or all, of the data provided by users may be required for the smooth functioning of the app, and that we may be legally required to store certain data.

6. Security

Rheintacho has implemented a number of suitable technical and organisational measures to safeguard your data against loss, misuse or tampering and prevent unauthorised or illegal access to your data and the processing thereof.

7. Data subject rights

You are entitled to receive information on your personal data stored by us along with the right to rectify incorrect data, restrict processing and demand erasure. Please note that our employees are subject to data confidentiality as per Art. 53 of the Federal Data Protection Act as last amended by Article 12 of the Act of 20 November 2019 (Bundesdatenschutzgesetz – BDSG).

You can receive information on your personal data stored by us at any time by sending an email to our data protection officer at datenschutz@rheintacho.de. Please also contact our data protection officer if you would like to withdraw your consent to the storage of your data and assert your rights to rectify and erase your data.
